They are for the Tupe and Tuhirangi lines. At the previous AGM the Tupe line chose not to elect a trustee. Due to personal commitments the Tuhirangi trustee resigned last year. Both these lines have people holding these positions as ex-officio officers. As trustees can only be elected at an AGM, those whanau may wish to take the opportunity to elect trustees to fill these positions.
